Kumho Tyre Australia Pty Ltd ("Kumho Tyre Australia") is pleased to offer you this Road Hazard Warranty ("Warranty").

Please note that this Warranty is optional additional protection and in order to submit a claim and be covered by this Warranty, you must have purchased this Warranty at the time original tyres were purchased.

TERMS AND CONDITIONS

1. This Warranty applies only to the original purchaser (or owner) named on this warranty card.
2. This Warranty applies only to tyres imported to Australia by Kumho Tyre Australia. Tyres purchased and normally used outside Australia are not covered under this Warranty.
3. This Warranty applies only to the following Kumho tyre patterns: KU19, KU22, KU31, KU27 and KU39. Run flat tyres are not covered by this Warranty.
4. This Warranty applies only to the following tyre sizes: 55 series and lower, and 15 inch and greater.
5. This Warranty applies only to tyre damage caused by colliding with gutters, potholes or foreign objects on tarmac roads within Australia ("Road Hazards"). This Warranty does not apply to any damage that can be repaired, including but not limited to a nail penetrating the tread.
6. Subject to paragraph 7, if a Road Hazard causes damage to a tyre specified above, that tyre will be replaced with a Kumho tyre of the same size and pattern, if available. If not available, a comparable quality tyre will be substituted. The replacement of a tyre under this Warranty is free of charge to the vehicle stated below for the damage caused by a Road Hazard for the first 25% of the useable tread-life of the tyre, or 12 months from the date of purchase, whichever occurs first.
7. Tyres will not be covered by this Warranty if damage is caused:
 - By an act of vandalism, theft, wilful abuse and neglect.
 - Use in motorsport, and non-tarmac roads.
 - Use in other than normal driving conditions or in commercial situations such as taxis, hire cars etc.
 - As a result of improper use or operation, including without limitation improper inflation pressure, overloading, use of an improper rim, vehicle misalignment, tyre/wheel assembly/ imbalance or other vehicle conditions, defects or characteristics, worn suspension components, improper mounting or demounting, misuse, misapplication, negligence, tyre spinning, tyre chain damage, chemical contamination (such as sealers, fillers etc), fire or other externally generated heat, water or other material trapped inside the tyre during mounting, tyre alteration, racing or competition use, failure to rotate properly or regularly, or to properly maintain tyres.
8. An original invoice for the purchase of these tyres must be kept displaying the purchase of this Warranty and must be presented upon lodging a claim.
9. Kumho accepts no responsibility for injury to persons or damage to vehicles as a result of the Kumho tyres being damaged.
10. Kumho reserves the right to inspect damaged tyres before providing a free replacement tyre.
11. To lodge a claim, present this voucher (signed by the tyre dealer at time of purchase to the tyre dealer from whom you purchased the tyres, namely the Tyre Dealership below). We suggest you keep this voucher in your glove box with your service log book.
12. To the extent permitted by law, liabilities for consequential damages are disclaimed. In no case shall Kumho Tyre Australia's liability exceed the original cost of the purchased tyres.

This Warranty is in addition to other rights and remedies that you have under a law in relation to the goods that we provide. Further, our goods come with guarantees that cannot be excluded under Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
